- Approval of Agenda motion to approve agenda Phil and Knut. Motion carries.
- Consent Calendar
 - Update on Security Grant (signed last month) report on progress on the work. Ace reported that he has spoken to Chris Drury with Clear Choice every week. Once the EHP part is done, he will send it to Miss Ross regarding the grant. If she doesn't like it we may have to change some things. We already paid \$20K down. Once the grant is approved by Miss Ross MCC DC will be reimbursed for the \$20K we put down. Ace hopes to submit the grant request to Miss Ross by the end of this week.
 - Pastoral Report Motion to receive: Phil and Johanna. Motion passed.
 - Prep for congregational Forum (November 6) and Congregational Meeting (November 20):
 - Board recruiting (2 positions +election of position Ace currently appointed) –
 Knut's and Lilah's are the positions that are coming up.
 - Reminder that the person with the fewest votes takes the board vacancy with the least amount of years. Phil asked if Knut and Lilah have any interest in running again.
 - Ace is filling a vacancy by board appointment through November and would need to run to continue to fill the position which runs for one more year.
 Board recruiting should begin by communicating the vacancies and publishing it in the eBlasts and church bulletin.
 - Discussion about how people will vote in person on paper or electronically or a hybrid of both. The Tech Team which meets on Friday will discuss ways voting could be executed at the Congregational meeting. The "check in" process could also be done electronically.
 - By-laws: any suggested changes this year? We had by-law changes last year but none on the agenda for this year. Do we know of any? Last year the by-law changes passed unanimously.
 - Call for reports Pastors report, board report, trustees report, and the minutes from the last meeting are usually presented. Johanna noted we are not doing a financial report because that will be presented with the

- o Treasurer's Report:
 - O **Truist general Fund**: -\$27,174.72 this is a negative amount. But there is the BHT Grant money also in the account. The reason for the negative amount in the General Fund is because the donations are not keeping up with expenses.
 - o **Truist Buchanan** fund: \$689.77
 - o **EagleBank Emergency Fund**: \$25K
 - Charles Schwab FRFTF \$582,773.49. and \$63,464.54 in the Money Market account after \$40K was transferred from the bequest of Larry Rowe to Truist.
 - \$75,706.01 remaining from the \$175K that was approved by the congregation. This is a subset of the \$582,773.49 in the Charles Schwab account.
 - Terri asked about using some of the funds from the BHT to pay for some of the things the church needs such as paying vendors and livestreaming. Pastor Dwayne mentioned that he talked with the chairman of BHT and understands that these spending ideas would be in alignment with the way BHT would want to see the funds used. What is not acceptable to BHT would be to pay for salaries.
 - Terri would like to know at a future BOD meeting how the work of Tom Melzoni is benefiting the church. We have to-date paid Mr. Melzoni over \$13K. And still our expenses are outstripping our income.
 - Terri also said she would like to know if it would be acceptable to move the final \$63K from the bequest of Larry Rowe to the general fund. Motion to move the \$63K made by Knut and Terri. Motion carried.
 - o Motion to receive the Treasurers report- Phil and Knut. Motion passed.

 - Signing schedule- Terri will be out of town the next couple of weeks and will
 not be able to be in the church office the next two weekends. Knut can come
 in. Ace can come in but Terri needs to have him added to the signing
 authority for Truist bank.
