

BOARD OF DIRECTORS ZOOM MEETING Meeting Minutes

June 21, 2022, 7PM

1. Song (Dr. Carla) CeCe Winans "The goodness of god" and Scripture (Phil) – James 1:19-20

- 2. Approval of Agenda Knut and Terri moved the approval of the agenda. Motion approved.
- 3. Consent Calendar Motion to receive the consent calendar Lilah and Terri, motion unanimous.
 - Pastoral Report
 - Trustees Report Update from Scott regarding the Security Grant.
 - Scott reported that we received a proposal to spend the security grant money to upgrade the doors to the building, gate access to the parking lot to make them electronic and able to be controlled via the cloud. And also to improve lighting and other features. The proposal is from Clear Connection and someone named Chris Drury. The total cost is for \$41K. 50% is required upfront. Once we approve, the proposal goes to DC homeland security department for approval.
 - o Lilah noted that the proposal mentioned Clear Channel may use third party subcontractors, and how will that effect their warranty.
 - O Knut noted that there is a monthly service charge for the electronic access once it's installed of about \$60/month and will that be a recurring charge forever? Scott said it appears so yes. However we are paying ADT for camera monitoring. Melvin noted that we are paying ADT for the security system and features we already have.
 - Ace asked about what the timeline is for this work. The timeline is included in the Project Management Plan (PMP) included with the proposal.
 - Phil asked about how we found Clear Channel. Scott explained that Clear Channel approached us based upon prior work that they had done with Mark Kornamann. Pastor Dwayne added that he had interviewed Clear Channel previously.
 - Terri asked about who's responsible for the taxes on this grant money. Melvin said there is a workshop explaining grant disbursement. Taxes are not included. Pricing excludes taxes. Ace asked about our tax exempt status as a church. Melvin said that some vendors accept the tax exempt status and others do not.

- Rev. Cathy asked what are the next steps? As per Rev. Dwayne the next steps are clarification of our questions, and then based on the answers, vote on the proposal, ideally before the next BOD meeting.

4. Treasurer's Report:

- \$37,705.64 in the Truist General Fund.
- \$689.75 in the Buchanan Fund
- \$25K in the EagleBank Emergency Fund
- \$523,593.48 in the Charles Schwab Far Reaching Faith Trust Fund (FRFTF)
- \$61, 639.71 (in addition to the above balance amount) is what remains from the Bequest from Larry Rowe estate to the FRFTF.
- Of the \$175K Approved by Congregation last June 2021 has a remaining balance of \$75,706.01. \$99,293.99 spent mostly on the roof and HVAC repairs.
- Rental Income is reduced this month is \$2816.29 and is coming from 2 tenants. Only 2 of the 3 units are currently rented. 1 moved out. As per Rev. Cathy the property management company for 472 Ridge street is getting quotes for the repairs. There is no timeline for when the empty, damaged unit of 472 Ridge St. could resume generating income.
- Terri gave a presentation of her spreadsheet regarding the disbursement for the HVAC repairs showing we have paid approximately \$111K. Based on Terri's estimate we are very close to paying off this expense. Terri will continue her research to make sure we don't overpay the vendor Harris.
- Motion to receive the Treasurers report, moved by Knut and Ace, approved unanimously.

 - Signing schedule Ace volunteered, but first needs to be registered with Amnify electronic check signing company to be a signatory. Lilah offered to volunteer the 3rd of July. Knut said he will be at church for livestreaming so he will be available. Lilah will be available on the 17th.
