December 20, 2022, 7PM

  - Update on Security Grant (signed in September) report on progress on the work. Bobbi asked about who the security grant is coming from. Pastor Dwayne explained that it is a grant we applied for and were ultimately approved. - Charles Schwab Far Reaching Faith Trust Fund (FRFTF) \$509,969.99
- Money Market Account from Bequests \$3772.78
- Remaining balance of \$175K approved by the congregation in June 2021 is \$57,079.98

  - Johanna asked if there is a way Easy Tithe could help us prepare our giving statements.
  - Terri reviewed the Signing schedule for holidays and forward

  - Chocolatté and Rev. Carla volunteered to help with the financial responsibilities and the year end giving statements.
  - Discussion of Easy Tithes features such as deducting the fee for the transaction from your donation.
  - Johanna suggested perhaps looking at another vendor for the tithing service as Easy Tithe does not integrate with our livestreaming, Facebook, etc. It would be nice to find another service that is less expensive, more flexible, and secure.
