- Approval of Agenda Phil and Bobbi. Approved.
- Board Officer Elections
 - =Clerk Phil expressed interest in staying on as Clerk. Bobbi and Terri motioned Phil. Approved.

=Vice Clerk - Bobbi expressed interest in being the Vice Clerk. Phil and Ace nominated. Approved.

=Treasurer – Terri expressed interest in staying on as the Treasurer. Chocolatté and Phil. Approved.

= Vice Treasurer – Chocolatté expressed interest in the Vice Treasurer. Phil and Terri. Approved.

=Vice Moderator - Johanna expressed interest in being the Vice Moderator. Ace and Terri motioned. Approved.

=At large - Ace expressed interest in the At-Large position. Phil and Terri motioned. Approved.

- Approval of Meeting minutes from December. Bobbi and Johanna. Approved.
- Consent Calendar
 - Update on Security Grant (signed in September) report on progress on the work. Ace reported on the update on the security grant. Erik Colaizzi is going to be the project manager for Clear Connection. Ace, and Pastor Dwayne met with him last Tuesday and reviewed everything that needs to be done with the gate, card reader, etc. Mr. Colaizzi will get back to Ace to schedule the work on the gate.
 - Rev. Cathy asked about the problems with the inside lights as well as the outside lights. Specifically the timer for the lights which is located on the inside of the electrical room.
 - Terri asked about the reimbursement piece and asked Ace to inquire when we might see reimbursement from the grant for these expenditures. Ace took an action to report back on the reimbursement piece.

- Pastoral Report Motion to receive consent calendar and reports Phil and Bobbi. Received.
- Treasurer's Report
 - Truist General Fund (-\$8566.14). This is due to the fact that \$79,625.77 is still available from the BHT grant funds
 - Trust Buchanan Fund \$759.82
 - EagleBank Emergency Fund \$21,523.63
 - Charles Schwab \$530,597.80 Far reaching Faith Trust Fund (FRFTF)
 - Of the \$175K approved by the Congregation in June 2021 the remaining balance is \$57,079.98.
 - Electronic payments Johanna asked why the church hasn't thought about doing electronic payments from the church to people we write checks to. Rev. Cathy and Chocolatte said it was probably due to the need to have 2 check signers and reviewers. Although we could discuss how we could go electronic in the future. Rev Dwayne suggested that due to year end giving statement and the budget activity the following month, we should add this to the agenda for discussion on April's agenda.
 - Motion to approve Knut Panknin as a back-up signatory. Knut is still listed with the bank and this would give the BOD flexibility. Phil and Terri. Approved.
 - Rev. Dwayne mentioned that Ace has been approved to sign and Chocolatté needs to sign the confidentiality agreement to be able to sign.
 - Terri said in a future BOD meeting she would like the Board's thoughts on the comingling of the BHT funds with the General Funds. Johanna mentioned that her discomfort comes from the fact that the BHT funds are restricted funds to be used only for certain things. Rev. Dwayne said that anytime someone sees a negative or red ink, that it does raise a flag for the Board. Everyone understands that the BHT funds are restricted and can only be used for certain things, and the fact that we are keeping them separate is adequate enough.
 - Johanna asked about EasyTithe and perhaps there could be a better service out there. However there could be a challenge if we decide to change from EasyTithe. Johanna is compiling a list of services for the BOD to review in order to be better able to capture donations from various platforms.
 - Motion to receive the Treasurers report: Phil and Johanna. Approved.

Cathy also knows an estate attorney that will be briefing interested members on how they can create an estate plan with giving intentions.
